## ELIGIBLE VOTER - BOTH TYPES

#1-You can request an overseas postal ballot if you are a registered voter who is living off-island, such as students and persons away for medical care.

**OR**

#2-You can request a locally delivered postal ballot if you are a registered voter living in the Cayman Islands but will be away from the islands on Election Day.

### IMPORTANT NOTICES:

1. If you receive more than one ballot paper, remember that it is illegal to vote more than once at the same general election or by-election.

&

2. As a 'registered' absent elector at this election you **cannot vote at the polling station but only by post.**





**NOTE A**  
IF YOU ARE A RESIDENT ON THE ISLANDS  
**BUT**  
YOU WILL BE AWAY ON ELECTION DAY  
YOU MUST ALSO PROVIDE THE FOLLOWING:

1. A copy of purchased\* airline tickets showing the individual will be travelling or off-island on Election Day.

\* Please note, only purchased tickets will be accepted. Reservations that have not been paid for in full do not qualify.

2. Clearly print the **local street address** for the ballots to be delivered locally.

**NOTE B**  
IF YOU ARE CURRENTLY AWAY **AND** YOU  
WILL  
BE AWAY FOR ELECTION DAY  
Clearly print the **full overseas street address**  
for the postal ballot to be couriered to.

**NOTE C**  
An application to be treated as an absent elector shall be made to the registering officer in Form B or C. The form shall be completed by the applicant and signed by that elector in the presence of a witness, who must then also sign the form and write in that person's full name in the spaces provided

**NOTE D**  
If an applicant is not able, because of physical or other disability, to complete or sign the form without assistance, the form may be completed or signed, or both, in the presence of the applicant and in the applicant's name by some other person, not being a candidate for election or the agent of such a candidate.

Where this is done, the person completing or signing the form must also complete and sign the portion of **Form B or C** headed "**Declaration of person who assists an applicant**", in both cases in the presence of a witness who shall then also sign both parts of the form and write in that person's (the witness) full name in the spaces provided.
